#### Statement of Significance

The Red Hill Hydraulic Gold Sluicing Site consists of a large sluicing pit containing a network of pebble dumps and tail races. The slopes of the hill below the pit have been extensively ground sluiced, and the gullies draining from the northern and southern sides of the hill have been deeply excavated by high pressure water. The water was brought to area by a race constructed by the River Loddon and Tributaries Water Company in the early 1870s. This race was re-used and repaired in 1906 and 1937. The hill also has a number of house sites, an extensive network of water races and sluice heads, and two dumps of iron sluicing pipe.

The Red Hill Hydraulic Gold Sluicing Site is of historical, archaeological and scientific importance to the State of Victoria.

The Red Hill Hydraulic Gold Sluicing Site is historically and scientifically important as a characteristic and well preserved example of an early form of gold mining. Gold mining sites are of crucial importance for the pivotal role they have played since 1851 in the development of Victoria. Hydraulic sluicing of alluvial gold deposits is an important key ingredient in an understanding of gold mining technology as it was employed in country where water was plentiful and perennial.

The Red Hill Hydraulic Gold Sluicing Site is archaeologically important for its potential to yield artefacts and evidence which will be able to provide significant information about the cultural history of gold mining and the gold seekers themselves.

## **Permit Exemptions**

#### **General Exemptions:**

General exemptions apply to all places and objects included in the Victorian Heritage Register (VHR). General exemptions have been designed to allow everyday activities, maintenance and changes to your property, which don't harm its cultural heritage significance, to proceed without the need to obtain approvals under the Heritage Act 2017.

Places of worship: In some circumstances, you can alter a place of worship to accommodate religious practices without a permit, but you must <u>notify</u> the Executive Director of Heritage Victoria before you start the works or activities at least 20 business days before the works or activities are to commence.

Subdivision/consolidation: Permit exemptions exist for some subdivisions and consolidations. If the subdivision or consolidation is in accordance with a planning permit granted under Part 4 of the *Planning and Environment Act 1987* and the application for the planning permit was referred to the Executive Director of Heritage Victoria as a determining referral authority, a permit is not required.

Specific exemptions may also apply to your registered place or object. If applicable, these are listed below. Specific exemptions are tailored to the conservation and management needs of an individual registered place or object and set out works and activities that are exempt from the requirements of a permit. Specific exemptions prevail if they conflict with general exemptions.

#### **Specific Exemptions:**

#### General Conditions:

1. All exempted alterations are to be planned and carried out in a manner which prevents damage to the fabric of

the registered place or object.

- 2. Should it become apparent during further inspection or the carrying out of alterations that original or previously hidden or inaccessible details of the place or object are revealed which relate to the significance of the place or object, then the exemption covering such alteration shall cease and the Executive Director shall be notified as soon as possible.
- 3. If there is a conservation policy and plan approved by the Executive Director, all works shall be in accordance with it.
- 4. Nothing in this declaration prevents the Executive Director from amending or rescinding all or any of the permit exemptions.

Nothing in this declaration exempts owners or their agents from the responsibility to seek relevant planning or building permits from the responsible authority where applicable.

No permits are required for the following classes of works provided they are carried out in accordance with the provisions of the Conservation Plan For Historic Mining Sites prepared by David Bannear in 1996.

- \* Mineral Exploration
- \* Fire suppression duties
- \* Timber production
- \* Weed and vermin control
- \* Public safety
- \* Rehabilitation

#### NOTICE OF REGISTRATION

As Executive Director for the purpose of the Heritage Act, I give notice under Section 46 that the Victorian Heritage Register is amended by including the Heritage Register Number 1230 in the category described as a Heritage and Archaeological Place:

Red Hill Hydraulic Gold Sluicing Site, Castlemaine Historic Area, Vaughan, Mount Alexander Shire Council.

#### Extent:

- 1. All of the Crown land including a large sluicing pit complete with pebble dumps and tail races; and all the ground and gully sluicing, water races, dumps of sluicing pipe, and house sites and any other remains of hydraulic gold workings within a radius of 500 metres of a point with Australian Map Grid co-ordinates E533 N852 on 1:100,000 map sheet number 7723 Castlemaine.
- 2. The River Loddon Water Supply Company's water race, and all the Crown land either side of it for 10 metres, from where the race crosses Irishtown Track, E N on 1:100,000 map sheet number 7723 Castlemaine to E N on 1:100,000 map sheet number 7723 Castlemaine.
- 3. All the Crown Land including water race flume within a radius of 150 metres of a point with the Australian Map Grid co-ordinates.
