#### Statement of Significance

The Gambetta mine comprises evidence of a former reef mining venture including mullock heaps, shafts, building platforms, tracks, drains and scatters of artefacts. The Gambetta mine is of historical and scientific significance at the local level. The Gambetta mine is of historical significance as evidence of former reef mining activity in the Omeo area, and as one of the later mines to operate. It is historically important for its role in continuing mining traditions after the alluvial mining had petered out and hydraulic sluicing was banned. The site is of scientific significance for its potential to reveal further information through archaeological investigation.

Interpretation of Site

The site features mullock heaps, shafts, earthworks and evidence of building platforms remain from the Gambetta Mines which operated from approximately 1882 to 1911. At least two water races ran to the site, with a small dam located nearby, presumably to supply water to the steam engine. Evidence of a track running down the gully from the Polar Star and Gambetta Mines, probably relates to transport of ore to the battery. As discussed above, a track which runs south east from the battery site was probably the original access route. The place is currently on privately owned land.

## **History**

A series of late nineteenth century mines were operated along the hillsides of Dry Gully. Among them, the Gambetta and Polar Star mines. Mullock heaps, shafts, earthworks and evidence of building platforms remain from these mines. Further down the same gully was the State Battery. The Gambetta Mine was floated by entrepreneurs from Ballarat operating sporadically commencing about in 1882 and still operating in 1911, with the later venture restarted under the name "New Gambetta G.M. Co. N.L. The Polar Star mine operated for a similar period. A battery was erected on Dry Gully near the Gambetta Reef in 1882, under the name "Omeo Pioneer Quartz Crushing Machine" funded by local miners and farmers with T Easton one of the directors. It was described as: ...a battery of five heads of stampers, with the usual accessories, and is to be worked by a 10horse power steam engine, manufactured by Messrs. Rushton and Proctor, Lincoln, England. Though secondhand, it appears to be in good order. When erected, it is estimated that the total cost will amount to nearly £6000. A few years later the battery changed hands: The future of mining in Omeo is beginning to look a little brighter. A gentleman from Sydney, Mr Constable, has purchased the engine and two head battery at Dry Gully, also the Surprise lease and Southern Cross claim. The Gambetta and Polar Star mines were located on the hillside above Dry Gully, south of the road. The Battery site was located on the junction of Dry Gully and a small branch creek. At least two water races ran to the site, with a small dam located nearby, presumably to supply water to the steam engine. Evidence of a track running down the gully from the Polar Star and Gambetta Mines, probably relates to transport of ore to the battery. A track which runs south east from the battery site was probably the original access route.
