

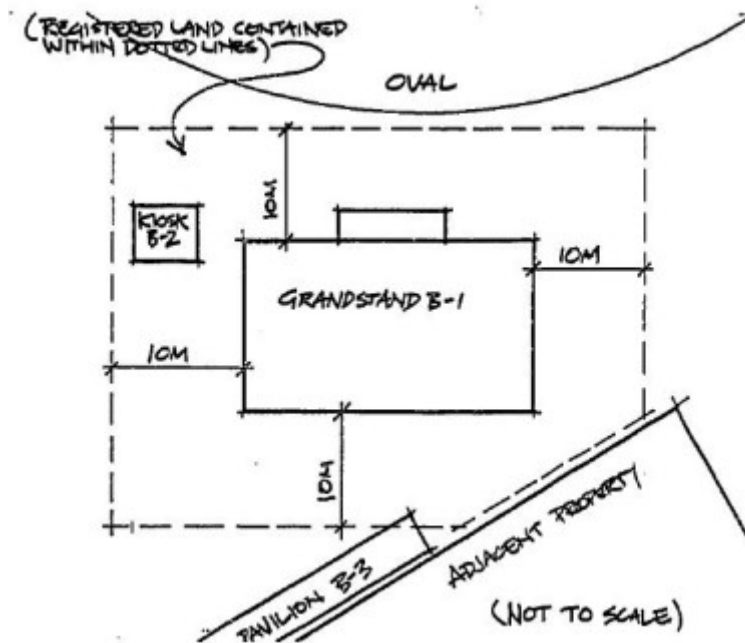

## Statement of Significance

Last updated on - March 19, 1997

What is significant?

The Grandstand at Benalla Showgrounds, which was constructed in 1913, is a timber-framed grandstand with distinguishing curved roof to the seating section, and half-curved roof over the clubrooms at the rear. It is divided into seven bays formed by chamfered timber posts and queen post trusses. Each bay has shingled and corrugated iron panels with a timber and cast iron lace frieze.

How is it significant?

The Grandstand at Benalla Showgrounds is of architectural importance to the State of Victoria.

Why is it significant?

The Grandstand at the Benalla Showgrounds is architecturally important as a rare example of a surviving timber-framed grandstand, with barrel roof and ornate timber cast iron lace frieze.

## Permit Exemptions

### General Exemptions:

General exemptions apply to all places and objects included in the Victorian Heritage Register (VHR). General exemptions have been designed to allow everyday activities, maintenance and changes to your property, which don't harm its cultural heritage significance, to proceed without the need to obtain approvals under the Heritage Act 2017.

**Places of worship:** In some circumstances, you can alter a place of worship to accommodate religious practices without a permit, but you must [notify](#) the Executive Director of Heritage Victoria before you start the works or activities at least 20 business days before the works or activities are to commence.

**Subdivision/consolidation:** Permit exemptions exist for some subdivisions and consolidations. If the subdivision or consolidation is in accordance with a planning permit granted under Part 4 of the *Planning and Environment Act 1987* and the application for the planning permit was referred to the Executive Director of Heritage Victoria as a determining referral authority, a permit is not required.

Specific exemptions may also apply to your registered place or object. If applicable, these are listed below. Specific exemptions are tailored to the conservation and management needs of an individual registered place or object and set out works and activities that are exempt from the requirements of a permit. Specific exemptions prevail if they conflict with general exemptions.

### AMENDMENT OF REGISTER OF HISTORIC BUILDINGS

Historic Building No. 976.

Grandstand, Benalla Showgrounds, Bridge Street West, Benalla.

(To the extent of:

1. All the buildings known as the Grandstand, Benalla Showgrounds marked B-1 (but excluding the kiosk and pavilion marked B2 and B3) respectively on Plan 6050044 (A), signed by the Chairperson, Historic Buildings Council and held by the Director, Historic Buildings Council.
2. All the land surrounding the Grandstand, Benalla Showgrounds to a distance of 10 metres from the base of the building, except to a distance of 6 metres from the south-west corner of the building, being part of Crown Land Showground Extension, Gazettal Number 79-1635 Reserves 2261, marked L-1 on Plan 6050044 (A), signed by the Chairperson, Historic Buildings Council and held by the Director, Historic Buildings Council.)
