**Departure** 

Men were working in the hold the day fire broke out. No coals or dangerously inflammable matter on board. Fire discovered about 3 am, hatches battened down and tarpaulins placed over them. Boats from HMCS Victoria came from Williamstown and gave assistance. Tugs Hercules and Lioness later in the morning towed the ship away from other shipping to St Kilda bank. After some difficulties it was scuttled, and heeled over in about 3-3/4

fathoms, with yards and masts standing and sails bent. Loss estimated at about 10,000 pounds. No floating engine available to assist at fire on this occasion. At 4.30 pm, the fire party from the Victoria returned with the entire crew of ten from the E. Norris, arrested at the request of the master, on suspicion of having set fire to the ship. Brought before the Williamstown Police Court, the charge was dismissed - not the slightest evidence against the accused. No indication of how the fire had started. Mr. Isbister of Williamstown contracted to remove the vessel. It was pumped out, towed across the Bay and moored in shallow water near mouth of Yarra River. In 1882 Mr. A. White won the tender for the removal of the E. NORRIS from Hobsons Bay, off White's slip at Williamstown.
